Coraschatten Puppy Sales Contract

Coraschatten is dedicated to the improvement of the Deutsch Langhaar (DL) in accordance with the breeding standards of the Deutsch Langhaar-Gruppe Nord Amerika (DL-GNA). The intent of this contract is to assure that the dogs produced from this kennel will receive appropriate care and will be protected from indiscriminate breeding, so that the outstanding qualities of upland and waterfowl hunting ability, temperament, and health are enhanced. It is to be recognized that this DL puppy represents many years of careful breeding and is considered to be of extreme value both to the seller and to the buyer. Seller guarantees that all shots are current, dewclaws are removed, and deworming accomplished as necessary. This puppy also has a tattoo on its right ear with his/her Deutsch Langhaar Verband (DLV) registration number. The buyer agrees to provide all necessary veterinary services in the future and shall maintain the dog in a contained area with adequate shelter.

The buyer agrees to pay a nonrefundable deposit of \$200.00 to reserve the right to purchase a puppy from this litter. This will be a deposit towards the purchase price of the puppy. The balance to be paid prior to the time of shipping/possession is \$ _____. Any shipping charges (airfare, health certificate, crate) will be the buyer's responsibility. This puppy and registration papers applying to this puppy will remain the property of the seller until final payment is made. Deposits are only refundable if no puppy is available in this litter. Buyer will maintain the best possible standards of canine health, cleanliness and veterinary care, including mental health such as contact with people, and exposure birds and the outside world.

A full refund will be given for any puppy found ill by veterinary exam during the first 72 hours. Seller guarantees the sire and dam of this puppy are healthy and free of any temperament or genetic defects at time of breeding. Coraschatten DLs are also guaranteed to be functionally free

of hereditary genetic diseases for up to thirty-six (36) months of age. If your puppy develops a life-threatening or life-altering illness (a condition that impedes the dog's ability to hunt) that is found to be hereditary in nature (as diagnosed by your veterinarian) before the age of thirty-six (36) months, the seller will do one of three things: (1) replace the puppy from another mutually agreed to comparable breeding when such a breeding becomes available, (2) refund the full purchase price of the puppy, or (3) provide a partial refund. In order to receive the replacement puppy or the full purchase price refund, the original puppy must be returned. If the buyer chooses to keep the puppy, a refund of one-half (1/2) the original purchase price will be made pending confirmation from the buyer's veterinarian that the puppy has been spayed or neutered. The buyer must provide written documentation from his/her veterinarian that the puppy has been altered.

The buyer is strongly encouraged to run this DL through a natural ability hunting test offered by the DL-GNA (www.dl-gna.org), the JGV-USA (www.jgv-usa.org) or the Verein Deutsch Drahthaar-Group North America (VDD-GNA; www.vdd-gna.org). The buyer is also strongly encouraged to have this dog's hips x-rayed. Buyer agrees this dog may only be bred in accordance with the breeding regulations set in place by the Deutsch Langhaar-Gruppe Nord Amerika (DL-GNA; www.dl-gna.org). Each Coraschatten DL will be sold with Limited Registration in NAVHDA. Once your puppy has been certified for breeding by the DL-GNA, the seller will immediately lift the limited registration with NAVHDA so any puppies produced could be registered there if the buyer wishes.

Buyer agrees that, should they ever decide to part with this dog, the seller will have first option to take the dog back. Should the buyer's situation change in that they can no longer care for the dog, they must notify the seller immediately. The seller will take the dog back or assist in finding a suitable home for it. AT NO TIME will this Coraschatten DL be surrendered to a shelter or humane society. The seller will always assist in placing this dog.

The buyer agrees that, should they not meet any and all terms of this agreement, the seller may repossess this animal, after giving 10 days written notice. The buyer agrees to pay any lawyer fees, court costs, traveling and shipping expenses, and other miscellaneous expenses incurred by the seller in repossessing this animal.

Buyer agrees that any further transfers of this Coraschatten DL are bound by this agreement. Seller certifies that all statements made in this contract are true and correct to the best of their knowledge.
